Transport as a service	\$36.50 - Roebourne \$52.50 - Wickham / Cossack \$91.50 - Point Samson \$150.50 - Karratha All trip prices are one way. If group travel is done, the costs will be attributed equally.

Support at Home funding levels

effective 1st Nov 2025

The Support at Home program replaces the Home Care Packages (HCP) and introduces eight funding levels based on assessed care needs. Each level has a quarterly budget and an annual total:

1	\$2,682.75	\$10,731.00
2	\$4,008.61	\$16,034.45
3	\$5,491.43	\$21,965.70
4	\$7,424.10	\$29,696.40
5	\$9,924.35	\$39,697.40

7	\$14,537.04	\$58,148.15
8	\$19,526.59	\$78,106.35

To encourage timely use of services, only a limited portion of unused funds can be carried forward—specifically, up to \$1,000 or 10% of your quarterly budget (whichever is higher). Any remaining unspent funds beyond this threshold will not roll over into the next quarter.

Under the Support at Home program, grandfathered clients—those receiving or approved for a Home Care Package before 12 September 2024—will retain their existing contribution arrangements, ensuring they are no worse off.



Client Contributions



Under support at home, the government may ask you to contribute to the cost of your independence and everyday living services, this is based on your income and assets.

*Contribution rates are set as a percentage of the price for each service.

Full Pensioner	0%	5%	17.5%
Part pensioner and Commonwealth seniors health care card eligible	0%	Between 5% & 50% depending on income & assets	Between 17.5% & 80% depending on income & assets
Self-funded retiree	0%	50%	80%

If a grandfathered client was not previously required to pay a contribution, they will continue to pay nothing. Should a client feel unable to meet their assessed contribution, we can assist you with a hardship application that must be lodged with Services Australia to determine eligibility for financial relief.
